The thesis has outstanding new points after:

Secondly, the thesis has built up theoretical issues about many crimes, which have important implications in criminal legal science and trial practice such as the concept, characteristics and forms of expression of crime. many criminals. Third, the thesis systematically and comprehensively analyzes the role of criminal aggravating circumstances related to many crimes in the General Part and the Specific Crimes Section in the Penal Codes with three different roles: are valuable aggravating circumstances of criminal liability in a penalty frame , are signs of crime and signs of penalty framing .

Fourth, the thesis elaborates on the current situation of applying the aggravating circumstances of criminal liability related to many crimes in Vietnam today on both methods. the law and real presently France law. Since then, the thesis has pointed out the limitations and inadequacies and identified the causes of these limitations and inadequacies. In the regulations and practice of applying aggravating circumstances of criminal liability related to many crimes in Vietnam's criminal law.
